Maria Virginia de Barzaga y Diaz

Born January 6, 1898 in New York, New York, Maria Virginia de Barzaga was baptised on July 23, 1898 by the late Rev. Philip Cardella at the Catholic Church of St. Francis Xavier, New York, NY. After a few years living with her parents in the Gramercy Park area of New York City, the family moved to the Bayamo area of Cuba. She was part of the socialite scene of Cuba attending many functions and her closest friends included: Hilda Heydrich de Bernard , Carlos Prio Socorras , Sergio Carbo , Piedad Zenea de Bobadilla , Gracia Camara de Bandujo , and **M. Francisca Camara de Zarraga** . She and her husband Miguel Blanco owned a beautiful home in Miramar, Marianao, Cuba and raised three children. Maria Virginia, her mother and other Diaz' owned stock investments in the Matahambre Mines of copper and gold in Pinar Del Rio, Cuba owned by her uncle Manuel Luciano Diaz. Among some of the houses her family owned included a house in Guanabo for which her daughter Margarita resided for a few years. When Fidel Castro took over Cuba's government, Maria Virginia obtained visas for herself and family and returned to the United States on June 22, 1962 via Pan American airlines to Miami, Florida. She spent the remainder of her years keeping in touch with family and living with her daughter Margarita's family in Summit, New Jersey and Atlanta, Georgia. She died on May 24, 1976 and is buried at the College Park Cemetery in Georgia.

Mi «Socio» Carlitos

Yo soy el campeón metiendo la pata en el teléfono. Mi lista de errores garrafales y equivocaciones es enorme, sobre todo cuando los cubanos me llaman inmediatamente después del saludo me preguntan:

«¿Ya sabes quién te habla?»...

Pero la historia que más me gusta de mis fallos me sucedió cuando vivía en Miami en la casa de Carlos Zárraga junto a Vicente Méndez y los guajiros del Escambray.

Una mañana suena el teléfono y yo lo contesto. Me dice la persona: «Hola ¿puedo hablar con Zárraga?» y le respondo: «¿De parte de quién?», y me dice: «Por favor, dígame que de parte de Carlos»... Le digo: «Zárraga no se encuentra, llámelo más tarde»...

Pero durante una semana las llamadas infructuosas del tal Carlos se convirtieron en cotidianas, y yo siempre era el que contestaba el teléfono. Un día el señor me preguntó: «Chico y ¿cuál es tu nombre?» y yo le respondí: «Yo soy Estebita», y comenzó a llamarme «Estebita», y por ende yo enseguidita pasé a llamarlo a él «Carlitos»...

Y, poco a poco, fui cogiendo más confianza envalentonado porque «el nuevo amigo mío» parecía disfrutar enormemente de la forma irrespetuosa en que yo lo trataba. Ya le conocía la voz y enseguida que la oía le soltaba: «¿Que pasó, Carlitos, como tú estás mi socio?» y el solohecho de decirle eso le producía tremenda risa a mi «socio» Carlitos...

Ya, aunque Carlos Zárraga estuviera en la casa, yo no le pasaba llamada, la verdad es que yo ya estaba convencido de que Carlitos «al que llamaba era a mi» porque ni por Zárraga me preguntaba. Yo pensaba «este debe ser un viejo aburrido de Hialeah que está loco por hablar con cualquiera» y yo le daba por la vena del gusto.

Ya Carlitos sabía casi toda mi corta vida en Güines, sabía el nombre de mis padres y hasta la calle donde yo nací, pero yo no sabía nada de él, y cuando le preguntaba me decía: «Oh, mi vida no tiene importancia, ha sido una vida muy simple, te aburrirías si te contara»..

Y yo, en el colmo de los atrevimientos, le ripostaba: «No fastidies, Carlitos, que tú sueñas más viejo que Matusalén y algo tendrás que contarme, dime aunque sea una mentira».

Y riéndose me decía «Estás equivocado, yo solamente soy unos poquitos años mayor que tú». Y yo le decía: «No seas mentiroso, viejo, que tú debes tener más de 60 años». Y me decía: «Bueno, tú me pediste que te dijera una mentira y ya te la dije»...

Una mañana me dice: «¿Tú eres de Güines, no?... Yo le contesto que «Sí» y me pregunta: «¿Por casualidad conociste allí al Alcalde Jaime Quintero?» y le respondo: «Claro que sí, Jaime era mi primo y padrino.. Y contento me dijo: «Muchacho, pues Jaimie fue muy buen amigo mío». Y eso acercó un poco más «al simpático y cordial anciano»...

Normalmente a las personas mayores no les gustan los atrevimientos de los jóvenes pero este viejo parecía encantado de la vida con mis cosas.

Me pregunta un día: «Chico y ¿a qué tú te dedicas?» y le respondo: «En este momento solamente a tumbar a Castro» y riéndose me dice: «Pues, fíjate que ese también es el oficio mío». Y lo único que se me ocurrió decirle fue: «Bueno, entonces al igual que yo tú te debes estar comiendo un cable»... Soltó una carcajada.

Pero un buen día (cuando yo estaba de lo más feliz entreteniéndolo «al pobre viejo aburrido de Hialeah») se me acercó Carlos Zárraga y me preguntó: «¿Esa llamada es para mí?». No me quedó más remedio y tapando el auricular le dije a Zárraga: «Sí, chico, es un viejo que te ha llamado como 20 veces, es Carlitos, es de lo más chévere»... Carlos agarró el teléfono y se puso a hablar un largo rato con «mi amigo». Zárraga colgó, me llamó y me miró fijamente esperando ver mi reacción cuando me decía: «Sí, tú tienes mucha razón, el ex Presidente CARLOS PRÍO SOCARRAS es de lo más chévere»... **FIN**

Latin Americans Will Continue to Invest in South Florida Real Estate Market / Sonnenblick-Goldman Predicts

Miami, FL - May 24, 1999 - South Florida's commercial real estate markets will continue to enjoy high occupancy levels and rental rate growth as a result of the local economy's vibrancy and the lack of development activity, predicted Manuel de Zarraga, Managing Director of Sonnenblick-Goldman Company's Miami office. De Zarraga also noted that although the declining Brazilian economy (Florida's leading trading partner) will negatively impact certain sectors of the real estate market this summer, South Florida will continue to evolve as a megalopolis that has a highly diversified economy and is increasingly becoming a serious participant in the South American economy. This evolution, in turn, will continue to command the attention of major institutional investors for South Florida commercial real estate.

Hotel Market

The economic difficulties currently being experienced in Brazil may negatively impact certain sectors of the lodging markets in South Florida and Orlando this summer, de Zarraga commented. As the cost of travel for Brazilians to the United States has increased by nearly 50% over the past three months, tourist areas like Orlando may experience a drop in occupancy rates due to a sharp drop in Brazilian traffic. Reductions in lodging business in Florida resulting from the absence of Brazilian tourists may be significantly offset by anticipated strong domestic summer travel demand. Much of the large budget group business that originated from Brazil and targeted downtown Miami will also be down dramatically this summer. Additionally, the potential overbuilding of luxury hotels in Miami and limited service hotels throughout South Florida are areas of concern, de Zarraga added.

Retail Market

Retail sales in certain areas of South Florida, like downtown Miami, will also experience reductions in sales volumes with the loss of Brazilian shoppers. Before the recent devaluation of the Reais, Brazilians bought many American goods and products and then funded their travel expenses with the savings they accrued by shopping in the US, noted de Zarraga. However, the Brazilian economy has recently showed strong signs of stabilizing with the strengthened Reais, falling interest rates, and inflation levels below expectations, de Zarraga added.

Renewed confidence amongst Brazilian consumers should translate into improved sales at Brazil's limited number of regional malls and shopping centers. As a result, American investors are beginning to refocus on the excellent potentials of investing in Brazil's emerging regional mall and shopping center markets.

Office / Industrial Market

The South Florida office markets should not experience any appreciable impact from the economic issues affecting Brazil, Colombia, Ecuador or Venezuela. The underlying demand fundamentals for office space driven by the vibrant U.S. economy overcome any contractions of office space needs by banks, trading companies and finance firms serving Latin America. The industrial warehouse markets will behave in a manner similar to that of the office markets, however in certain areas of Dade County certain large industrial space users that were primarily involved in exports to Brazil will significantly reduce their space usage. Most of the industrial spaces that become available are quickly absorbed by users involved in the vibrant domestic markets.

Multi-family Market

Historically, Latin Americans have invested large amounts of capital in Florida's residential condominium units. This trend will continue throughout 1999 and the year 2000 and this capital will originate from a diverse group of Latin American countries, de Zarraga said. For example, Venezuela will be particularly active in flight capital due to the perceived political uncertainty and Ecuador will see significant flight capital because there is a severe lack of confidence in the country's banking

MIAMI—De todo Miami-Dade, cientos acudieron a la Pequeña Habana para ser testigos de un acto especial. La parroquia de San Juan Bosco inauguraba un nuevo templo que muchos, incluido el Arzobispo de Miami, comparan a una catedral.

“Ya se está hablando de la catedral de la calle Flagler”, dijo el arzobispo John Clement Favalora provocando los aplausos de la multitud.

“Este templo representa el esfuerzo de muchas personas y 38 años de trabajo de un hombre”, dijo señalando al párroco Mons. Emilio Vallina.

La construcción del nuevo templo ha costado 2.3 millones, sin contar los bancos y los vitrales que fueron donados. La deuda hoy es de 1.4 millones.

Mons. Vallina piensa que el nuevo templo puede ser “un recuerdo de nuestro paso por La Florida” y cuando mira hacia atrás, el Párroco repite convencido que “el Señor ha sido muy bueno con los cubanos, los nicaragüenses y tantos pueblos como han pasado por aquí”.

PLANNING BLAMED

Sporting a wavy roofline, airy atrium and snazzy terrazzo floors, Concourse H at Miami International Airport was a 1998 architectural prize winner.

Perez-Zarraga said bad planning is to blame. He said airport planners cut the deluge system from the plans because it cost \$850,000. «We were asked by the county to take it out as a cost-saving measure,» he said.

While trying to save money on safety features, airport managers drove up costs by continually changing the design of Concourse H, even during construction.

«Changes in airport administration, county managers and county commissioners slow things down,» said Perez-Zarraga, who has worked at the airport since the early 1980s. «As a general rule, the changes result in a overall review of the construction program. And the price goes up.»

Local Mediation Programs

Mediation programs provide an alternative method of resolving complaints without having to go to court. Through the mediation process, the individuals involved in a dispute work out their own solutions with the help of a mediator. The mediator does not enforce a decision on the individuals, but helps guide them in reaching a solution. Since the individuals involved in the dispute play active roles in resolving the program, they usually are comfortable and supportive of the solution.

Successful mediations often result in written agreements that are signed by both individuals in a dispute. If the parties do not reach a mutually agreeable solution, either or both of the parties may still file a court action.

Mediation procedures are voluntary, and usually take place in one or more sessions. Mediators usually are either trained, volunteer nonlawyers who reside in the community, or are paid individuals with backgrounds in law, psychology, or counseling. The mediator's role is to work with both parties in a dispute to identify the issues, reduce misunderstandings, clarify priorities, vent emotions, find points of agreement, explore new areas of compromise, and negotiate an agreement.
